

# 2025 Midyear Labor Activity in Manufacturing Report

(January-June)





# About This Report

People Results provides industry subject matter expertise and relevant and timely information about labor activity. People Results' 2025 Midyear Labor Activity in Manufacturing Report includes an analysis of national, regional, and state representation petitions and elections (RC, RD, and RM)¹ as reported by the National Labor Relations Board (NLRB) during 2024 and the first six months of 2025.

# Dear Industry Colleagues,

So far in 2025, manufacturing has seen continued union activity, driven largely by efforts from the International Brotherhood of Teamsters (IBT), the United Steelworkers (USW), and the United Auto Workers (UAW). Of note, in the first 6 months of the year, there have been 24 manufacturing strikes that resulted in the idling of 9,329 workers.

While traditional manufacturing sectors like automotive, aerospace, and textiles have been a hotspot for activity, emerging industries have become a target for unions, too. Recently, UAW has shown an increased interest in new electric vehicle (EV) battery plants—particularly in the South—including the Ultium Cells battery manufacturing joint venture in Tennessee and the BlueOval SK battery plant in Kentucky. Organizing drives continue to emphasize issues like wages and inflation, job protection and security, workload and safety protections, and health and retirement benefits. Notably, employees are forecasted to see the largest increase in health insurance premiums in over a decade, with costs rising 8 percent<sup>2</sup>—a factor that may add fuel to future organizing drives.

In People Results' most recent Labor Activity in Manufacturing Report, which we distributed earlier this year, we encouraged you to assess how your organization is proactively addressing employee concerns and engagement to mitigate—and even eliminate—potential risks of unionization by asking questions like:

- Are your managers equipped to recognize and respond to early signs of workplace dissatisfaction?
- Do you have clear communication channels in place to ensure employees feel heard and valued?
- Do your leaders regularly recognize their employees' productivity and efforts on the job? Employees, and particularly younger employees, seek to be recognized for their efforts and coached for excellence to achieve individual rewards.

At People Results, we understand the unique labor and employee relations challenges the manufacturing industry is facing, and we are dedicated to helping manufacturers of all sizes create specific, tailored employee engagement strategies that address the root causes and tackle these issues effectively. We hope you find the up-to-date information enclosed in this report helpful as we close out the year, and we look forward to supporting you in 2026 and beyond.


# **Executive Summary**

# NLRB REPRESENTATION PETITIONS AND ELECTIONS<sup>3,4</sup>

During 2024, 241 representation petitions were filed in manufacturing. In the first 6 months of 2025, there were 102 representation petitions filed, and unions were elected as a result of 65 percent of the 60 representation elections held.

The International Brotherhood of Teamsters (IBT) remains the most active union in the manufacturing industry, accounting for 27 percent of representation petitions filed and 48 percent of elections held in the first 6 months of 2025. The United Steelworkers (USW) is the next most active union, accounting for 10 percent of petitions filed and 12 percent of elections held during that same period.

Also in the first half of 2025, there have been 24 manufacturing strikes that resulted in the idling of 9,329 workers. New York has seen the most strike activity in the industry in the last decade.


#### REPRESENTATION PETITIONS FILED

Unions filed 206 RC petitions in 2024. That plus the 35 employer-filed RM petitions resulted in 241 representation petitions filed in the year. This was the most representation petitions filed in the manufacturing industry in the last decade. Through the first 6 months of 2025, 102 representation petitions have been filed—86 RC and 16 RM petitions.



#### UNION WINS IN REPRESENTATION ELECTIONS

Despite steadily increasing over the past decade, union win rates in manufacturing continue to remain lower than in other industries. In the first 6 months of 2025, unions won 65 percent of representation elections held—which will represent a decade high if this rate holds for the rest of the year. In non-manufacturing industries, unions enjoyed an 80 percent win rate.

# Manufacturing vs. Non-Manufacturing Industries (2016-June 30, 2025)



## **UNION WINS IN DECERTIFICATION ELECTIONS**

There have been 19 decertification elections held in manufacturing in the first half of 2025—unions maintained recognition in 53 percent of them. Outside of manufacturing, unions maintained recognition in 35 percent of the 55 decertification elections held this year.


# Manufacturing vs. Non-Manufacturing Industries (2016-June 30, 2025)

# UNION SUCCESS IN REPRESENTATION ELECTIONS COMPARED TO NUMBER OF ELECTIONS

The chart below shows the union win rate compared to the number of elections held each year. In 2024, unions won 60 percent of 173 representation elections. So far in 2025, unions have won 65 percent of the 60 representation elections held.













# Appendix C: NLRB Definitions

#### WHAT IS THE NATIONAL LABOR RELATIONS BOARD?

The National Labor Relations Board (NLRB) is an independent federal agency established to enforce the National Labor Relations Act (NLRA). As an independent agency, the NLRB is not part of any other government agency, such as the Department of Labor.

Congress has empowered the NLRB to conduct secret ballot elections so employees may exercise a free choice whether a union should represent them for bargaining purposes. A secret ballot election will be conducted only when a petition requesting an election is filed. Such a petition should be filed with the Regional Office in the area where the unit of employees is located. All Regional Offices have petition forms that are available upon request and without cost.

#### **TYPES OF PETITIONS**

## 1. Certification of Representative (RC)

This petition, which is normally filed by a union, seeks an election to determine whether employees wish to be represented by a union. It must be supported by the signatures of 30 percent or more of the employees in the bargaining unit being sought. These signatures may be on paper. This designation or "showing of interest" contains a statement that the employees want to be represented for collective-bargaining purposes by a specific labor organization. The showing of interest must be signed by each employee, and each employee's signature must be dated.

# 2. Decertification (RD)

This petition, which can be filed by an individual, seeks an election to determine whether the authority of a union to act as a bargaining representative of employees should continue. It must be supported by the signatures of 30 percent or more of the employees in the bargaining unit represented by the union. These signatures may be on separate cards or a single piece of paper. This showing of interest contains a statement that the employees do not wish to be represented for collective-bargaining purposes by the existing labor organization. The showing of interest must be signed by each employee, and each employee's signature must be dated.

## 3. Withdrawal of Union-Security Authority (UD)

A "UD petition," which can also be filed by an individual, seeks an election to determine whether to continue the union's contractual authority to require that employees make certain lawful payments to the union to retain their jobs. It must be supported by the signatures of 30 percent or more of the employees in the bargaining unit covered by the union-security agreement. These signatures may be on separate cards or a single piece of paper. This showing of interest states that the employees no longer want their collective bargaining agreement to contain a union-security provision. The showing of interest must be signed by each employee, and each employee's signature must be dated.

# 4. Employer Petition (RM)

This petition is filed by an employer for an election when one or more unions claim to represent the employer's employees or when the employer has reasonable grounds for believing the union that is the current collective-bargaining representative no longer represents a majority of employees. In the latter case, the petition must be supported by the evidence or "objective considerations" relied on by the employer for believing that the union no longer represents a majority of its employees.

## 5. Unit Clarification (UC)

This petition seeks to clarify the scope of an existing bargaining unit by, for example, determining whether a new classification is properly a part of that unit. The petition may be filed by either the employer or the union.

# 6. Amendment of Certification (AC)

This petition seeks the amendment of an outstanding certification of a union to reflect changed circumstances, such as changes in the name or affiliation of the union. This petition may be filed by a union or an employer.
