

2025 Midyear Labor Activity in Transportation and Logistics Report

(January-June)



About This Report

People Results provides transportation industry subject matter expertise and relevant and timely information about labor activity.

People Results' 2025 Midyear Labor Activity in Transportation and Logistics Report includes an analysis of national, regional, and state representation petitions and elections (RC, RD, and RM)¹ as reported by the National Labor Relations Board (NLRB) during 2024 and the first six months of 2025.

Dear Industry Leaders,

So far in 2025, we have seen continued union activity across the U.S. transportation and logistics sector. The International Brotherhood of Teamsters (IBT) remains the most active union in the industry, followed by the Amalgamated Transit Union (ATU)—together accounting for 60 percent of petitions filed and 45 percent of elections held. Of note, there have been 7 transportation strikes in the first 6 months of 2025 that resulted in the idling of 2,645 workers.

Moreover, there has been a widespread use of strikes, pickets, and public campaignsmost notably at Amazon, Santa Clara Valley Transportation Authority (VTA), and Costco. Unions are continuing to raise issues around wages and pay and health, safety, and working conditions. There is also an increased push for job protection and security, stemming from a rise in subcontracting and automation. Another factor likely to come into play in future organizing is an 8 percent forecasted increase in healthcare premiums, the largest in over a decade.2 Organizing campaigns continue to affect private logistics operations like Amazon, UPS, and FedEx, as well as government or publicly-funded logistics operations like VTA and USPS.

In People Results' most recent Labor Activity in Transportation and Logistics Report, which we distributed earlier this year, we encouraged you to assess how your organization is proactively addressing employee concerns and engagement to mitigate—and even eliminate—potential risks of unionization by asking questions like:

- Are your managers equipped to recognize and respond to early signs of workplace dissatisfaction?
- Do you have clear communication channels in place to ensure employees feel heard and valued?
- Do your leaders regularly recognize their employees' productivity and efforts on the job?
 Employees, and particularly younger employees, seek to be recognized for their efforts and coached for excellence to achieve individual rewards.

While this recommendation holds true now, we encourage you to take your findings one step further and put a strategic plan into place. This plan should include:

- Briefings for executive teams to help key stakeholders understand the implications of recent organizing targeting transportation and logistics organizations
- Labor relations readiness assessments and training to identify and address potential labor relations issues
- Internal and external communication strategies
- Workforce transformation implementation
- The leveraging of data and people analytics to gain valuable insights into vulnerabilities and segment your workforce
- Strategies to support leadership engagement with colleagues

In summary, with union activity on the upswing, it's important to take the time to listen to employees and turn their concerns into meaningful change. People Results' expert labor relations and employee engagement consultants help transportation and logistics organizations achieve this by assessing vulnerabilities and labor readiness and developing and implementing preventative strategies. Executive Summary

NLRB REPRESENTATION PETITIONS AND ELECTIONS^{3,4}

During 2024, 206 representation petitions were filed in transportation. In the first 6 months of 2025, there were 61 representation petitions filed, and unions were elected as a result of 79 percent of the 47 representation elections held.

The International Brotherhood of Teamsters (IBT) remains the most active union in the transportation industry, accounting for 49 percent of representation petitions filed and 30 percent of elections held in the first 6 months of 2025. The Amalgamated Transit Union (ATU) is the next most active union, accounting for 11 percent of petitions filed and 15 percent of elections held during that same period.

Also in the first half of 2025, there have been 7 transportation strikes that resulted in the idling of 2,645 workers. California has seen the most strike activity in the industry in the last decade.



National Summaries

REPRESENTATION PETITIONS FILED

Unions filed 173 RC petitions in 2024. That plus the 33 employer-filed RM petitions resulted in 206 representation petitions filed in the year. This was the most representation petitions filed in the transportation industry since 2017. Through the first 6 months of 2025, just 61 representation petitions have been filed—57 RC and 4 RM. When it comes to representation petitions, 2025 is on track to be one of the least active years in the history of the transportation industry.



UNION WINS IN REPRESENTATION ELECTIONS

Union win rates in transportation have remained fairly consistent over the last decade. These win rates are similar to win rates in other industries. In the first 6 months of 2025, unions won 79 percent of representation elections held in both transportation and non-transportation industries.

UNION WINS IN DECERTIFICATION ELECTIONS


There have been just 5 decertification elections held in transportation in the first half of 2025—unions maintained recognition in 40 percent of them. Outside of transportation, unions maintained recognition in 39 percent of the 69 decertification elections held this year.















Appendix C: NLRB Definitions

WHAT IS THE NATIONAL LABOR RELATIONS BOARD?

The National Labor Relations Board (NLRB) is an independent federal agency established to enforce the National Labor Relations Act (NLRA). As an independent agency, the NLRB is not part of any other government agency, such as the Department of Labor.

Congress has empowered the NLRB to conduct secret ballot elections so employees may exercise a free choice whether a union should represent them for bargaining purposes. A secret ballot election will be conducted only when a petition requesting an election is filed. Such a petition should be filed with the Regional Office in the area where the unit of employees is located. All Regional Offices have petition forms that are available upon request and without cost.

TYPES OF PETITIONS

1. Certification of Representative (RC)

This petition, which is normally filed by a union, seeks an election to determine whether employees wish to be represented by a union. It must be supported by the signatures of 30 percent or more of the employees in the bargaining unit being sought. These signatures may be on paper. This designation or "showing of interest" contains a statement that the employees want to be represented for collective-bargaining purposes by a specific labor organization. The showing of interest must be signed by each employee, and each employee's signature must be dated.

2. Decertification (RD)

This petition, which can be filed by an individual, seeks an election to determine whether the authority of a union to act as a bargaining representative of employees should continue. It must be supported by the signatures of 30 percent or more of the employees in the bargaining unit represented by the union. These signatures may be on separate cards or a single piece of paper. This showing of interest contains a statement that the employees do not wish to be represented for collective-bargaining purposes by the existing labor organization. The showing of interest must be signed by each employee, and each employee's signature must be dated.

3. Withdrawal of Union-Security Authority (UD)

A "UD petition," which can also be filed by an individual, seeks an election to determine whether to continue the union's contractual authority to require that employees make certain lawful payments to the union to retain their jobs. It must be supported by the signatures of 30 percent or more of the employees in the bargaining unit covered by the union-security agreement. These signatures may be on separate cards or a single piece of paper. This showing of interest states that the employees no longer want their collective bargaining agreement to contain a union-security provision. The showing of interest must be signed by each employee, and each employee's signature must be dated.

4. Employer Petition (RM)

This petition is filed by an employer for an election when one or more unions claim to represent the employer's employees or when the employer has reasonable grounds for believing the union that is the current collective-bargaining representative no longer represents a majority of employees. In the latter case, the petition must be supported by the evidence or "objective considerations" relied on by the employer for believing that the union no longer represents a majority of its employees.

5. Unit Clarification (UC)

This petition seeks to clarify the scope of an existing bargaining unit by, for example, determining whether a new classification is properly a part of that unit. The petition may be filed by either the employer or the union.

6. Amendment of Certification (AC)

This petition seeks the amendment of an outstanding certification of a union to reflect changed circumstances, such as changes in the name or affiliation of the union. This petition may be filed by a union or an employer.
